"The state of health IT in Australia and potential learnings for Hong Kong" & "Global Standards for Traceability in Healthcare Sector"

In Session 1, "The state of health IT in Australia and potential learnings for Hong Kong", Mr. David Rowlands, Managing Director, Direckt Consulting, shared his experience in developing eHealth programme in Australia, including the History of Australia's eHealth development, significant achievement of the Primary Care ICT implementation and clinical information quality concerns about HK eHealth development. 為推進衛生信息技術更好配合醫藥衛生體制 改革 加強境內外交流與合作 引領衛生信息化行 業發展,促進醫改目標實現,中國衛生信息學會 和《中國衛生信息管理雜誌社》聯合香港、澳門、 台灣地區衛生信息學術組織, 於7月18日-19 日在遼寧省大連市召開 2012 中國衛生信息技術 交流大會暨兩岸四地衛生信息化交流會議。主題 為創新、 實用、共贏。






## 2012 中國衛生信息技術交流大會暨兩岸四地衛生信息化交流會議:香港講者簡介

#### 鄧淑明博士

#### 電子健康聯盟創辦人

講題:香港電子健康發展慨況

摘要:香港政府於 2009 年實施電子健康記錄計畫,並採用經試驗計畫 驗證的元件組砌方式,以及公開、預設及共通的技術標準和程式,開發 以病人為本的電子健康記錄互通系統,供病人自願參與。第一階段電子 健康記錄計畫的目標,是在 2013-14 年度建立電子健康記錄互通平台, 連接所有公立和私家醫院,以及確保市場上能夠為私家醫生、診所及其 他醫療服務供應商,提供連接至電子健康記錄互通平台的電子醫療記 錄及電子病歷記錄系統。

講題:資訊安全與新技術應用(香港經驗)

摘要:在一般情況下,企業是不允許用戶從互聯網直接使用 ERP 或其他資訊系統,常見的解決方案是通過 Java 或 Dot Net 開發並建立互聯網應用層以規範使用者的行為。此方案只是把一些 ERP 系統功能外移,而開發量可大可小,最終尾大不掉。我們以 SAP ERP 做案例,通過基於Windows Sharepoint 對 SAP ERP 的集成、或通過 SAP ERP 對 SAP ERP的集成,在 ERP 以外建立一道額外的應用層,讓企業可以安心提供互聯網的服務,又避免過度開放系統,減低被入侵的風險。

講題:國際條碼標準在醫療護理用品供應鏈及防偽功能的應用

摘要:香港貨品編碼協會是以推廣及支援一系列的 GS1 全球通用編碼標準,為供應鏈管理提供最佳實務及應用技術。醫療藥品生產供應商可用國際條碼對藥品進行庫存、銷售管理,實現藥品追蹤及追溯功能。醫院可以通過條碼攜帶的資訊對醫療藥品的收貨及應用,進行追蹤管理,並記錄在病人的醫療處方及電子檔案中,確保病人的用藥安全,也可追溯患者用藥的所有情況。同時,結合條碼技術、驗證碼及查詢真偽訊息的共通平台,可做到檢驗藥品真偽的功能。

### eHR Public Consultation

eHR office launched a two-month consultation to solicit views on the Legal, Privacy and Security Framework for Electronic Health Record Sharing. The consultation was started from 12 December to 11 February 2012.

The Legal, Privacy and Security Framework aims to provide legal protection for the privacy of patients' health data and system security. In response to the public consultation, eHealth Consortium has expressed our view on the topic after collecting comments from our members. Please see the attached passage below for detail information.

The consultation report was published in June on the views received and briefed the Members of the Legislative Council panel on Health Service. The Report can be found at the eHealth Records Office website:

- 1. We support the establishment of The Electronic Health Record (eHR) Sharing System and we agree it could help to enhance the quality and efficiency of healthcare provided to our population.
- 2. We strongly urge the government to institute stronger safeguards to data privacy and security issues by additional tighter control on top of the present Personal Data (Privacy) Ordinance.
- 3. Although we agree this should be on a voluntary basis from the patients, we suggest that the citizens should be encouraged to participate as far as possible. Therefore an opt-out mechanism is more advisable than an opt-in mechanism. Anybody chooses to opt-in or opt-out should be required to sign in the sharing consent documents. And the government should encourage citizens for this sharing with adequate educational and promotion efforts. Otherwise, the number of citizens participating will be dismally small, as seen from the mere 170,000 citizens opt-in for the Public-Private-Interface electronic Patient Record sharing pilot for the last 4 years. The small percentage of participation will make this meaning platform a waste of investment and efforts.
- 4. The "need to know" principle is very vague. A more definitive definition or illustration would be helpful to the providers for guidance.
- 5. We agree on the scope of the sharable data but of the view that this scope should be expanded gradually to more items such as radiological images, etc in future.
- 6. We support the use of our Smart HK ID card for the purpose of authentication and also in giving consent. An additional health smart card, as use in Taiwan and Germany, are not suitable in Hong Kong, as it involves huge administrative efforts and money, and gives no additional benefits.
- 7. The practice of good compliance to the COP of data security and audit checks are often beyond the capacity of healthcare providers, especially solo private practitioners. The government should give extra resources and efforts in helping the providers in the initial set up and education and continuing technical support. Otherwise, this will greatly affect the support from the less resourceful healthcare providers in participating in the scheme.
- 8. While criminal sanction is appropriate for deliberate breach in the data access, there must be provision in the system not setting a trap to the ordinary users who are often IT illiterate to access data which are inappropriate.
- 9. The eHealth Consortium has also completed a pilot project on "A Validation Platform for eHealth Data Standards Conformity for the HK Community Wide eHealth Record Sharing: Paving the Road to the Future" which was sponsored by the Food and Health Bureau and Office of the Government Chief Information Office in 2009. Useful comments and suggestions were included in the Recommendation Report.
